POLICIES:

● **Before registering, we want you to be sure that Swell is the best fit for your family. Please familiarize yourself with our methods and policies before registering for lessons. The #1 indicator of swimmer success are parents/guardians who are supportive of their swimmers learning process and play an active role in their child's learning. We want you to ask questions, share successes and areas of concern, and be excited about the process!**

● Complete registration form. Email to registration@swellswim.com. You will receive an invoice for a \$100 (per swimmer) deposit when you submit your form. Once paid, we will begin scheduling your lesson appointments.

● You will have 2 business days, after a schedule is emailed, to accept, make changes as needed, and make your remaining payment.

● After two business days, your schedule may be removed to accommodate other swimmers.

● After confirming your schedule, you will receive an emailed invoice where you can pay the remaining balance for swim lesson appointments online. Your schedule is confirmed as soon as we receive your payment.

● The deposit is non-refundable. We will refund ONLY in the event we cannot accommodate your schedule.

● Once a schedule is accepted and payment received, we cannot move, reschedule, or refund lesson

appointments for any reason.

- Swell Swim School operates at full capacity. It is imperative that we provide the highest quality of attention and instruction to each of our swimmers. In order to ensure proper instructor scheduling, **we are not able to accommodate makeup lesson appointments for any reason.** These reasons include but are not limited to illness (including covid), vacations, unforeseen family emergencies, etc. You are welcome to add additional lessons at any time.
- We do our absolute best to uphold swimmers' schedules. In the event of inclement weather or other unforeseeable circumstances, we may need to reschedule, change teachers, or refund affected lesson appointments.
- While we strive to capture underwater pictures, please understand that underwater pictures cannot be guaranteed. Our foremost focus is always on ensuring a safe and enjoyable swimming experience.
- We expect everyone at Swell (parents, swimmers, teachers, etc) to treat each other with respect and kindness in all interactions

THINGS TO KNOW BEFORE YOUR LESSONS

- Please do not feed your child within 2 hours before the lesson. This is to prevent your child from having tummy aches & food come up with a burp.
- Only reusable swim diapers allowed. For best results, layer a disposable swim diaper inside the reusable swim diaper for easy clean up.
- We ask you to stay out of your child's view for the first lesson so your child can relate and bond to their teacher on a one-on-one basis, building trust, confidence, and love.
- The best way to contribute to your child's swim lessons is by being positive and giving lots of praise! Even if there are tears, talk about swim lessons in a positive way and be excited about progress!
- We highly recommend staying away from floating devices (puddle jumpers, floaties, life jackets) and goggles in the pool as they can reverse progress and create a false sense of security.

LIABILITY WAIVER

I, on behalf of myself and as the parent/legal guardian of the above swimmer, understand and acknowledge that there are risks inherent to the pool and sport-related activities conducted by Swell Swim School including, but not limited to, paralyzing injuries, brain injuries and death and that there are risk of injury or death that may result from, among other causes, the action or inaction of Swell Swim School, its owners, employees and/or agents, including negligent instruction, negligent operations, and dangerous or defective equipment owned or operated by Swell Swim School. I hereby assume any and all known and unknown risks of injury or death that may occur in connection with any and all Swell Swim School activities. I hereby release Swell Swim School and its owners, agents and employees from all liability to myself or my swimmer for any and all liability, claim, damages or demands for personal injury or death arising from or related to the activities conducted by Swell Swim School and at its facility. I agree that this release constitutes a complete release, discharge and waiver of any and all actions or causes of action against Swell Swim School (and its owners, agents and employees), arising in connection with any and all activities in which I or the swimmer participate related to the activities conducted by Swell Swim School or my or the swimmer's use of the facilities. To the extent permitted by law, I hereby agree to indemnify and hold harmless Swell Swim School (and its owners, agents and employees) from any and all liabilities or claims that may result from I or my child's participation at Swell Swim School.

EMERGENCY WAIVER

In the event of a medical emergency I hereby grant authorization to Swell Swim School to employ any and all health care providers to direct/give or order emergency medical treatment for myself and/or the swimmer. I further agree that Swell Swim School shall not be liable under any circumstances to anyone for exercising and/or ordering emergency medical treatment for myself and/or the above swimmer.
